

## **COMPETITION RULES**

### **1. ORGANIZER**

### **2. ENTRANTS**

## **9. DISPUTES**

The courts Antwerp shall have exclusive jurisdiction for all disputes concerning Guylian Advent Competition. In case a dispute resorts under the exclusive competency of the Justice of the Peace, the Justice of the Peace of the 1st district of Antwerp shall have exclusive jurisdiction.

In any such dispute, Entrants will under no circumstances be permitted to obtain compensation for, and hereby waives all rights to claim punitive, incidental or consequential damages or any other damages, including attorneys' fees, other than participant's actual out-of-pocket expenses (i.e. costs associated with entering this competition).
